GENERAL TERMS

Agreement: The undersigned Exhibitor hereby contracts with Landscape Communications, Inc. (LCI) for exhibition space at The Landscape Expo (TLE) as described herein. This agreement is subject to the rules, regulations and guidelines established by LCI and The Long Beach Convention Center. By signing below, Exhibitor agrees to abide by and be bound by them. *Event Rules and Regulations* are hereby incorporated into this Agreement and shall have the same force and effect as if fully set forth herein. Booth locations are assigned on a first-come-basis, based upon availability, each is sold in 10' x 10' increments. Booth rental includes: standard booth pipe & drape and side rail draping. Any additional services which need to be ordered are the responsibility of, and will be billed to the Exhibitor. These items may include (but are not limited to): electricity, booth signage and installation, carpet, furniture, etc. These need to be ordered from the show decorator or an authorized TLE vendor.

Payment Terms. 50% due now with signed contract. Balance of payment due net 30 days. Space reserved after August 15, 2018 requires full payment with signed contract.

Cancellation: All payment are non refundable.

Institute Conditions: Exhibitor agrees that show management reserves the authority to re-assign all exhibit space including the dimensions and locations within the show if deemed necessary. Show management will notify Exhibitor in writing if space assignments need to be changed prior to actual show dates.
